**SECTION 5. PROPERTY TAX LEVIED**

There is hereby levied for the fiscal year ending June 30, 2019, the following rate on each \$100 of assessed valuation of taxable property as listed as of January 1, 2017 for the purpose of raising revenue from current year's property tax as set forth in the foregoing estimate of revenue, and in order to finance a portion of the foregoing appropriations

**Ad Valorem Tax Rate: \$0.54**

Such rates based on an estimated assessment valuation of property for the purposes of taxation of \$ 167,562,037 with an estimated rate of collection of 92%.

**SECTION 6. ORDINANCE FILING**


Copies of this ordinance shall be filed with the Finance Officer, the Budget Officer, and Town Clerk, to be kept on file by them for their direction in the disbursement of Town Funds.

**SECTION 7. BUDGET ADMINISTRATION**

The Town Manager shall have the authority per G.S. 159-15 to transfer appropriations from one line item to another line item within a departmental budget so long as the total departmental appropriations, including capital outlay, shall not be increased.
